

# GSC ENERGY PRO

## *Limited Warranty*

Geothermal Supply Company, Inc. warrants GSC Energy Pro PE4710 Pipe and Fittings for a period of **50 Years** against defects in materials and workmanship.

This warranty is valid when GSC Energy Pro PE4710 Pipe and/or fusion Fitting are utilized and installed in a closed loop ground source heat pump system in accordance with accepted and approved industry guidelines and practices. This warranty applies only to GSC Energy Pro PE4710 Pipe and fusion Fittings. It does not apply to any fusion joining process or any other method or device used to join the pipe or fusion fitting performed by any other party. It does not apply to the design or installation of the system or any other component of the system.

Geothermal Supply Company, Inc. will replace, with a like quantity of new products, any GSC Energy Pro PE4710 Pipe or fusion Fittings that were installed and utilized as described above and that subsequently fail within fifty (50) years from the date of purchase due to a defect in materials or workmanship. For warranty claims occurring within one year after the date of purchase, the defective product (s) shall be replaced free of product and freight charges.

For warranty claims occurring during the second (2nd) through twenty first (21st) years after the date of purchase, the replacement product cost and freight expense borne by Geothermal Supply shall be calculated by reducing the then current price by 4 percent (4%) per year. For warranty claims occurring during the twenty second (22nd) through the fiftieth (50th) years after the date of purchase, the replacement product cost and freight expense borne by Geothermal Supply shall be calculated by reducing the then current price by eighty percent (80%).

APPLICABLE TO THE PRODUCTS IN QUESTION, THIS LIMITED WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, WHETHER WRITTEN, ORAL, EXPRESSED OR IMPLIED. GEOTHERMAL SUPPLY COMPANY, INC. DISCLAIMS ANY EXPRESS OR IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. GEOTHERMAL SUPPLY COMPANY, INC. SHALL NOT BE LIABLE FOR SPECIAL, INDIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES RELATING TO DEFECTS OF GSC ENERGY PRO PIPE AND FUSION FITTINGS, WHETHER USED SINGULARLY OR IN COMBINATION WITH OTHER PRODUCTS OR MATERIALS.
